# VETERANS BOARD MEETING JUNE 28, 2021

#### **MINUTES**

A meeting of the Veterans Board of Cuming County, in the State of Nebraska, was convened in open and public session at 7:30 a.m. on June 28, 2021, at West Point, Nebraska with Gatzemeyer, Feyerherm, Storm, Schwer, Kindschuh present. Brahmer absent.

Notice of the meeting was given in advance thereof by publication on the County website and postings on bulletin boards and media screens at the Cuming County Courthouse, two of the County's designated methods for giving notice. Availability of the agenda was communicated in the advance notice.

The VSO publicly stated to all in attendance that a current copy of the "Nebraska Open Meetings Act" was posted in the meeting room and on the County's website. A pamphlet form of the act is available upon request. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

#### FINANCIAL REPORT

### 1. EXPENSES

Gatzemeyer reported the following expenses for May 2021: Postage \$10.95, Cell Phone \$51.46, Meals \$24.05, Mileage Allowance \$17.92, Mileage Allowance \$17.92, Mileage Allowance \$17.92, Grave Markers \$1805.50, Fuel \$110.55, Equipment Rental (Copier) \$31.80, for a total of \$2211.43.

# 2. CUMING COUNTY VETERANS AID

Gatzemeyer reported that no applications were submitted this month. Balance of the checking account is currently \$1500. Copies of bank statements and a ledger were presented to verify account activity.

As a result 85 possible claims were identified, 14 death certificates have been requested to determine if veterans passed away from service-connected illness or condition and 1 new claim has been submitted. The goal is to have all deceased veterans' files scanned and reviewed by the end of the summer.

#### 5. GRAFF FUNERALS (3)

Gatzemeyer reported that he was contacted to assist with a military funeral for 3 Graff brothers in Bancroft on July 17.

#### 6. YEARLY REVIEW

Gatzemeyer reported that he will receive his yearly review by the Board of Supervisors on June 28. Lisa's review will be conducted by Steve Sill to include her performance in the Veterans Service Office and IT.
