### MINUTES

Gatzemeyer reported the following updates on the upcoming Veterans Roundtable event:


- A. RoundUp Grant was submitted; requested \$2500.00

- G. Phil Burns at F&M Bank offered to donate funds needed to pay any costs not covered


**NEXT MEETING**
