

**NOTICE OF PRIMARY ELECTION
MAY 12th, 2026**

Notice is hereby given that on Tuesday the 12th day of May 2026 at the usual polling places in the election precincts of Cuming County, Nebraska, a primary election will be held pursuant to Nebraska State Statute 32-802. The polls will open at 8:00 a.m. and close at 8:00 p.m. Said election will be for nominating candidates to various offices. ***Some races will not appear on the Primary Election ballot as the number of candidates filling does not exceed twice the number of vacancies; these candidates are declared nominated without opposition and advance to the November 3, 2026 General Election. Such races include the Cuming County Offices of: Assessor, Attorney, District Court Clerk, Clerk, Sheriff, Surveyor, Treasurer, West Point City Council, Wisner Mayor, Wisner City Council, Northeast Community College District 4, Lower Elkhorn Natural Resources District subdistrict 6, 7 and At Large, and West Point Public School, Pender Public School, Oakland-Craig Public School, Bancroft-Rosalie Public School, Lyons-Decatur Public School, Wisner-Pilger Public School, Scribner-Snyder Public School, Howells-Dodge Public School, and Logan View Public School, school board races*** Candidates shall not appear on the ballot in the primary election for the board of directors in Public Power District receiving annual gross revenue of less than forty million dollars, for Educational Service Unit Board, for Township Boards, and Village Trustee Board.
